The aims and objects of the society are :-

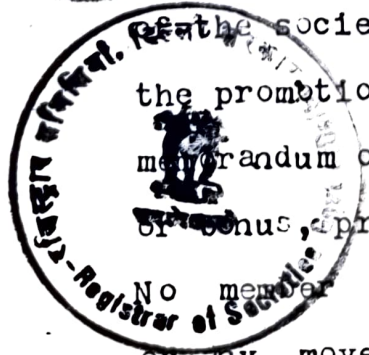
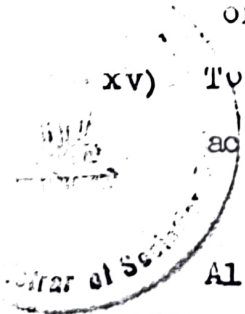
- i) To spread education in modern methods in Delhi.

- xv) To take up social welfare and income generrating activities for women.

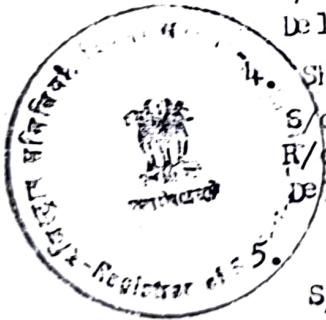

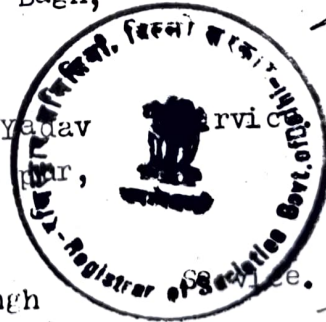
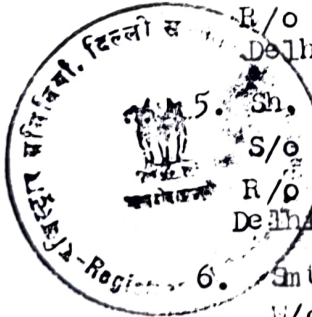

RULES AND REGULATION OF : " DAULATPURIA EDUCATIONAL SOCIETY " Vill. P.O. Daulat pur, Delhi. Kh. No. 14/1 and 8/21/2, Daulat pur, Delhi. -43.

MEMBERSHIP :- The membership of the society is open to any person or persons who have attained the stage of majority and fulfill the terms and conditions of the society without discrimination of the religion, caste, colour or creed but subject to approval of the governing body. If the membership is refused to a certain person or persons communicated to the person concerned.

2. SUBSCRIPTION :- Admission fee Rs. 5/- at the time of admission.

Subscriptions Rs. 100/- per annum.

3. TERMINATION OF MEMBERSHIP :-

The Governing body shall have the power to expell a member from the society on the following terms and conditions.

a) By no confidence motion passed 1/3rd majority of votes in the general body meetings.

b) Non payment of subscriptions continuously for three months from the due date.

c) On his/her written resignation.

d) He/She has not attended three consecutive meetings of the general body without any permission.

The reason of termination from the membership shall be communicated to the member concerned.

4. APPEAL :-

All the appeals should be preferred to the General body of the Society, the decision of the General body shall be final. The reason for rejection shall be communicated to the member concerned.

5. RE-ADMISSION :-

In case of Member is expelled by the General Body the same can be re-admitted, provided the member concerned, pays all upto date dues. The decision of general body shall be final this clause is applicable to the only clause (b).

6. GOVERNING BODY :-

The Governing body shall consider all members bearers as under :-

1. President : One.
2. Vice-President : One.
3. General Secretary
4. Secretary : One.
5. Treasurer
6. Member from



7. BANKS ACCOUNT :-

The Bank Account of the society shall be operated by the Treasurer and any one out of general secretary and President.

8. GENERAL BODY :-

All the members of the society will constitute the General Body.

9. FUNCTIONS OF THE GENERAL BODY :-

- a) To consider any business brought forwards by the governing body.
- b) There shall be an annual meeting of the general body in month of March in every year.
- c) Not less than 15 days prior notice shall be given than 15 days prior notice to the members before date of general body meetings enclosing the Agenda specifying the time, date and place and the quorum shall be 1/3rd.

10. SOURCE OF INCOME :-

- i) Admission fee.
- ii) Subscriptions.
- iii) Donations and special contributions.

The income of the society received from all sources will be utilised only for the promotion of the aims and objectives.

11. GOVERNING BODY :-

The strength of the governing body shall not be less than 7 and not more 21. The meeting of the Governing body shall be held as and when necessary for which 15 days clear notice will be required and the quorum shall be 1/3rd.

12. ELECTION AND QUORUM :-

The general body in its annual meeting will elect its office bearers and members after five years by secret ballot paper. However the same may be nominated unanimously with one third majority in the interest of the society. The quorum of the general body and the governing body shall be 1/3rd. The election proceedings of the society will be submitted in the office of the Registrar of societies, Delhi, immediately after election held by the society.

13. FUNCTION OF THE GOVERNING BODY :-

- a) To arrange finance if required from other Banks. Institutions or Individuals of/on reasonable terms and conditions and the Governing body as a whole shall be liable for its return.
- b) The Governing body shall make plan for the future programmes of the society,
- c) To publish literature and to propogate the system to approach the public pertaining to upliftment of the statue of society.
- d) To appoint terminate and fix duties of concerned staff of society.
- e) The governing body shall meet least in three months.
- f) To accept donation, articals, loans, grants, properties etc. from public of Associations, Adencier and Govt. Department in the interest and for the promotion of aims and objects of the society.

14. MANAGEMENT OF FUNDS :-

All the income of the society shall be deposited in the Nationalised Bank.

14. a) REGISTER OF MEMBERS :-

The society shall maintain at its registered office, a register of its members and shall enter therein the following pertainulars :-

- i) The names and addresses of the members.
- ii) The date of which the member was admitted.
- iii) The date of which the member was ceased to be such membership.

14. b) RIGHTS AND PRIVILEGES OF THE MEMBERS :-

All and every member of the society :-

- a) shall have one vote at every meeting.
- b) shall be ~~ent~~ entitled to participation the meetings and gathering of the society.
- c) shall have right to inspect the books of accounts. minutes of proceedings of the genedal body meeting working day during business hours by giving reasonable notice.
- d) shall be bound by the rules and regulations and/or by-laws of society which may g be framed from time to time.
- e) To administer the oath of the office and loyalty of the society and/or its constitution to the president.

14. c) FILLING UP CASUAL VACANCIES :-

The casual vacancies may be filled up by the resolution passed by both the governing body and general body, till the further election willbe held by the society.

15. POWER AND DUTIES OF THE OFFICE BEARERS :-

PRESIDENT :-

- a) He shall supervise all works and activities done by other office bearer of the society.
- b) He shall be the head of the society and preside over the meetings of the general body and governing body . He will have the right of casting of votes in case of tie.

VICE PRESIDENT :-

In the absence of the president, the vide president shall enjoy all powers and duties which are entrusted to the President. He will also help and assist the president in his work.

GENERAL SECRETARY :-

- a ) To sign on behalf of the spelety conduct its correspondence and to record the proceedings/meetings.

- b) To summon and attend the meeting of the general body.
- c) To call ordinary general body meeting if desired on the written request of at least and 1/3rd members of the general body.

SECRETARY :-

In the absence of the general secretary, the secretary enjoy all powers and duties which are entrusted the general Secretary. He will also hold/help and assist the secretary in his work.

TREASURER :-

He will/shall keep accounts of receipts and expenditure of the society and to furnish necessary information to the Governing body. He will keep within Rs. 3,000/- and the balance amount will have deposited in the Nationalised Bank.

AUDIT :-

The accounts of the society shall be audited at least once in an year by a qualified auditor appointed by the Governing body.

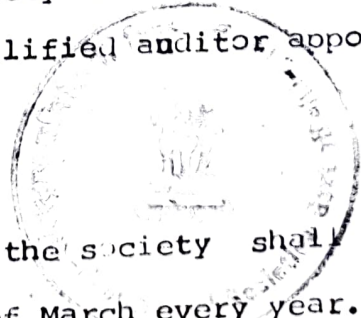
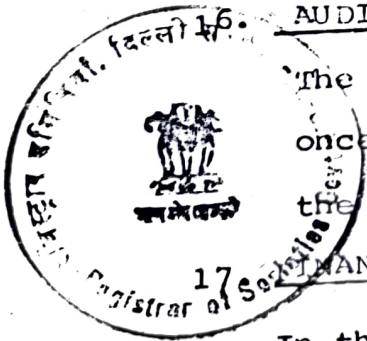
17. FINANCIAL YEAR :-
